Thanks to a generous grant from the Bush Foundation, the MNEA Board is able to provide scholarships for underrepresented evaluators and evaluation users to attend AEA 2019. Receiving the scholarship will cover the AEA conference registration and a one-year AEA membership and a one year MNEA membership (if not already an AEA/MNEA member). - Students (anyone currently enrolled as a student at the time of application submission)
- First time AEA conference attendees
